Athletic Director's Report:

First game will be with Prairie. Schedule still working on them. Change sometimes to fill gaps. Junior High Volleyball 13-14 players, combined practices twice a week.

Academic Report:

Jesse Feather presented behavior levels for teachers with a basic rubric/matrix: 1st time classroom level, redirect notify parent, 2nd time Parent, Teacher, Admin. Conference. 
